TERMS & CONDITIONS

The following terms and conditions are provided to ensure the success of your event at our venue. Please read this form and return signed to acknowledge confirmation of your booking.

BOOKINGS

A tentative booking can be made and held without payment for 7 days, after which, a hire fee must be made, or the space re-opens as available. A non-refundable deposit of the room hire fee and signed paperwork is required to secure and guarantee your event for your selected date.

There is a 15% surcharge on public holidays.

PAYMENTS

To secure the date and function space, a non-refundable deposit of the room hire fee is due. Final balance needs to be made in full in 14 days prior to your reservation date.

All bar tabs must be pre-paid. If the bar tab is extended, the balance must strictly be paid at the conclusion of the event.

CANCELLATIONS

Wah Wah is not responsible for interruption or cancellation of bookings due to circumstances beyond its reasonable control. The venue will not be liable for any costs related to the cancellation of the booking.

In the event of your event being cancelled the following terms apply:

Cancellation 14 days or more, room hire fee forfeited.

Cancellation 14 days or less, room hire fee forfeited, 100% catering costs forfeited, 100% refund on pre-paid beverages.

CATERING & BEVERAGES

Final numbers for beverage packages are due 14 days prior. There are no refunds from this date should there be a change in numbers.

Beverage packages must commence at the scheduled event start time.

Platters must be pre-ordered with selections and dietaries required 14 days prior, no refunds are available from this date.

The menu is subject to change.

Our team will endeavour to accommodate special dietaries; however, we cannot guarantee allergy-free meals. This is due to the potential of trace allergens in the working environment and supplied ingredients.

VENUE

Anyone under the age of 18 must exit the building by 9pm and are strictly forbidden to consume any alcohol whilst on the premises due to licensing regulations.

Our venue is licensed until 1AM, and may close earlier, however functions will officially conclude pre-midnight, as agreed at time of booking.

Subject to any designated smoking areas, smoking is prohibited in the premises.

OUTDOOR EVENT BOOKINGS

Please be mindful that although it is an incredible experience to host an event out over the water, we do ask that you take into consideration that there are always elements of risk with the weather. If you are hiring one of our outdoor spaces including Alfresco, West Wing and East Wing, potential inclement weather is beyond our control.

Wah Wah does not hold a secondary space as a back-up option to inclement weather. If you do have concerns regarding the weather as your event approaches, please contact us to discuss. If there are alternative options available, we will do our best to make those adjustments for you. Please understand this is not always an option if our other event spaces are fully booked.

RESPONSIBLE SERVICE OF ALCOHOL

Please note by signing this page you agree to the RSA practices as outlined in the Responsible Service of Alcohol policy. Wah Wah is a fully licenced venue and as such guests/hosts are not permitted to supply their own beverages.

DAMAGE & LOSS

The client will assume responsibility for any damage sustained to fixtures, fittings, property or equipment by yourself, your guests or outside contractors prior to, during or after your event.

Wah Wah is not responsible for the loss, damage or theft belonging to clients and their guests; the client will take full responsibility for any property, valuables, or money of themselves and their guests.

COMPLIANCE & NOISE

The client agrees to begin the function and vacate the function space at the scheduled times agreed upon. We allow access 30 minutes prior to your function/event commencement time. If you require earlier access, this must be arranged with your event coordinator in advance. Additional charges may apply.

Wah Wah Management has the right to request the removal from the Premises of any person behaving in a disorderly manner or the right to cancel the event due to unacceptable behaviour of guests.

MUSIC

Wah Wah will have live music, or our carefully selected playlists designed specifically for certain times of day to compliment your function.

If you are booking a shared space (West Wing), the music cannot be turned down for any presentations or speeches as such.

DECORATIONS & BELONGINGS

We allow 60 minutes bump in and bump out to your function/event time to come and decorate upon request. We request no adhesives on any surfaces or glitter type materials (including but not limited to - sticky tape, nails, glitter, glue, confetti or drillings).

All decorations and belongings must be removed at the end of your event unless pre-arranged with the team prior to the event. Additional fees apply if the venue staff are required to store and / or pack down your event. Wah Wah takes no responsibility for any items left on the premises.

FORCE MAJEURE

That in the event of Wah Wah being unable to perform and discharge their contractual obligations arising out of the Contract due to a Force Majeure Event, the venue shall be relieved of its obligations accruing and occurring during such time provided that the time for performance as specified in the agreement shall not be extended as a result thereof except by written agreement of both parties.
